#### 4. First-aid Measures

## 11. Toxicological Information

**EFFECT OF OVEREXPOSURE - INHALATION:** Under normal use conditions, this product is not expected to cause adverse health effects. During application and cure, this product releases methanol. Constituents of this product include crystalline silica which, if inhalable, may cause silicosis, a form of progressive pulmonary fibrosis. Inhalable crystalline silica is listed by IARC as a group I carcinogen (lung) based on sufficient evidence in occupationally exposed humans and sufficient evidence in animals. Crystalline silica is also listed by the NTP as a known human carcinogen. Constituents may also contain asbestiform or non-asbestiform tremolite or other silicates as impurities, and above de minimus exposure to these impurities in inhalable form may be carcinogenic or cause other serious lung problems.
